An actively managed multi-strategy, multitime frame, long biased hedge fund which aims to produce superior returns during moderate and low volatility flat to upwardly biased market conditions and protect capital and minimise drawdowns during periods where volatility is above average or markets are down trending.

The investment Manager is targeting an after fee, pre-tax return of the greater 5% per annum above the MSCI World Index (AUD) or 20% per annum on an absolute basis over a rolling 5 year period.



Withdrawal Requests will ordinarily be satisfied within 20 business days of the end of each quarter in which the 90 days' notice period expires, and subject to Investors having been invested in the Fund for the Minimum Term of 6 months The Fund will combine the approach of two or more different strategies allocated across two or more different portfolio allocations to achieve its objectives. The Fund will start with two strategies but may add more over time. The first strategy is a total return focused, concentrated, capital growth biased investment approach, focused on medium to long term investments in largely growth focused listed shares across the world's major investment markets. The second strategy is a short to medium term tactical swing trading strategy, which will target smaller but quicker returns in an active, concentrated, high turnover portfolio allocation.

The Investment Manager will deploy leverage across both portfolios by utilising a range of instruments including margin loans, derivatives and leveraged exchange traded funds (ETFs) to enhance the returns of the portfolio, but will also utilise such instruments in strategies such as short selling and hedging with a view to protecting the portfolio
